Between Tenant Agreement

The Between Tenant Agreement (BTA) offers landlords a way to automatically maintain service without interruption of service during times when units are vacant. When a tenant notifies us that they are moving, the account automatically reverts to the landlord's name until a new tenant signs up for service. With a BTA if AEL&P must end service for a tenant due to non-payment, we will notify the landlord to determine if the service should remain on, going forward as the landlord's responsibility. If the landlord prefers, the power will be disconnected. Lacking contact with the landlord, the account is placed in the landlord's name and written notification of this action is given.

I certify that the applicant is the responsible party of the premises for which this application is made. I have lawful authority to sign this application. My signature on this form authorizes AEL&P to conduct a credit check. I declare that the information provided is true, accurate, and complete to the best of my knowledge. The applicant agrees to pay the applicable rates and abide by the terms and conditions as prescribed by the AEL&P Utility Tariff. The applicant is responsible for the cost of all BTA services rendered until AEL&P receives notification either in person or in writing for the cancellation of this BTA. AEL&P may cancel the BTA if closing account balances are not paid when they are due. AEL&P has the right to collect the full amount owed from any one of the applicants where two or more parties make application for this BTA.
