## PSP Product Warranty

Coverage for the METERPRO (MJ-90-4J & MJ-90-5J)

\$10,000 Total Coverage

\$1,000 per Appliance

### Twenty Year Product Coverage

PSP will, at its option, repair or replace any METERPRO™ Surge Protection Device (SPD) that is defective or is damaged by an electrical surge (including those caused by lightning) for a period of twenty (20) years from date of purchase.

### **Twenty Year White Appliance Coverage**

Up to \$1,000 to repair or replace (whichever is less) residential "standard white appliances" which sustain surge damage. Maximum coverage per household: \$10,000. A "standard white appliance" is defined as a washer, dryer, refrigerator, freezer, HVAC unit inside house, sump pump, and other pumps inside the house, trash compactor, dishwasher, garbage disposal, stove and a stove with an integral microwave oven sharing the same wiring. Coverage is applicable only if the Service Entrance SPD (1) was fully functional immediately prior to the claim event, (2) was still under warranty, and (3) sustained surge damage as a result of the claim event.

External HVAC units that are mounted outside of the house are covered under this warranty only if the surge is found to have originated from the main circuit panel due to Service Entrance SPD failure. This provision is stated because all exterior wiring is vulnerable to surges caused by nearby lightning strikes. To best protect your exterior HVAC units, an additional surge protection device installed at the unit is highly recommended.

Exclusions to this warranty include all plug-in electronic equipment in the building (such as: computers, TV's, VCR's, phones, fax machines, etc.), central vacuum systems, hot tubs, pool pumps, well pumps, detached building/garages, security systems, intercom/radio systems, microwaves (that are not part of a stove), and garage door openers.

Microwaves (that are not part of a stove) and garage door openers (that are installed in an attached garage) can be covered, by this warranty, with the purchase of an approved single outlet surge protection device. This device has no warranty of its own, but when used in combination with one of the SPD's listed above, the warranty stated above will cover the connected microwave or garage door opener.

The above coverage applies to the user only and is the exclusive remedy under this warranty, whether based on contract, tort, including negligence, or otherwise. PSP reserves the right to audit damage, site and/or cost of repairs and may require a notarized proof of loss. Claims must be made within 30 days of damage. This warranty does not cover damage associated with sustained over voltages, vandalism, theft, normal wear and tear, obsolescence, abuse, unauthorized modification or alteration, misuse, improper installation or catastrophic events. Except as expressly provided by this warranty, PSP disclaims liability for any incidental, indirect, special or consequential damages arising out of the sale or use of any PSP products (including without limitation: lost business profits, loss of data and all freight, mileage, travel time and insurance charges associated with warranty coverage claims). Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights and you may have other rights which vary from state to state. This warranty is valid in the United States and Canada only.
